“Medieval Understandings of Participation”



Richard Cross is the Rev. John A. O’Brien Professor of Philosophy and Chair of the Department of Philosophy at the University of Notre Dame. His areas of interest are medieval philosophy and theology and history of philosophical theology. Professor Cross is the editor of *John Duns Scotus 1308-2008: The Opera Theologica of Scotus* (2012) and the author of *Duns Scotus on God*, Ashgate Studies in the History of Philosophical Theology (2005); *The Metaphysics of the Incarnation: Thomas Aquinas to Duns Scotus* (2002); *Duns Scotus*, Great Medieval Thinkers (1999); and *The Physics of Duns Scotus: The Scientific Context of a Theological Vision* (1998). Some of his recent articles include: “Baptism and Severe Cognitive Impairment in Some Medieval Theologies,” *International Journal of Systematic Theology* (forthcoming); and “Disability, Impairment, and Some Medieval Accounts of the Incarnation: Suggestions for a Theology of Personhood,” *Modern Theology* (2011). He is currently working on

several books and articles, including *Cognitive Psychology in John Duns Scotus*, *The Medieval Christian Philosophers*, and *Oxford Handbook of the Reception of Christian Theology*, edited with Sarah Coakley.

Stephen Gersh is Professor of Medieval Studies and Concurrent Professor in the Department of Philosophy at the University of Notre Dame. His areas of research and teaching include late ancient and medieval philosophy, medieval literary and music theory, modern continental philosophy, hermeneutics, and deconstruction. He is the author of numerous books on the history of the Platonic tradition including *From Iamblichus to Eriugena* (1978), *Middle Platonism and Neoplatonism*, (1986), *Concord in Discourse* (1998), *Reading Plato – Tracing Plato* (2005), *Neoplatonism after Derrida* (2006), and *Being Different* (2013). He is a former Fellow of Magdalene College, Cambridge and was named Solomon Katz Professor in the Humanities in the University of Washington in 2001.



Douglas Hedley, Templeton Fellow at the NDIAS (2013-2014), is Reader in Hermeneutics and Metaphysics at the University of Cambridge in the Faculty of Divinity. He specializes in Neoplatonism, the Cambridge Platonists, aspects of Romantic and Idealistic thought, and Philosophy of Religion. While in residence at the NDIAS, his research focuses on “The Iconic Imagination.”

His monographs include *Sacrifice Imagined: Violence, Atonement and the Sacred* (2011), *Living Forms of the Imagination* (2008), and *Aids to Reflection and the Mirror of the Spirit: Coleridge, Philosophy and Religion* (2000). He has published articles in *The Journal of the History of Ideas*, *Religious Studies*, and *Faith and Philosophy*. He is co-editor of the series *Studies in Philosophical Theology* published by Peeters of Leuven.

He is the Principal Investigator of a UK Arts and Humanities Research Council Grant ‘Revisioning Cambridge Platonism’ (2013) and has been a Visiting Fellow at the Center for Advanced Studies at the Ludwig Maximilians University of Munich (2012). He gave the Teape lectures in India (2006) and was the Alan Richardson Fellow at Durham University in 2004. In 2002 he was Visiting Professor at the EPHE, Sorbonne, Paris. He currently serves as co-chair of the Platonism/Neoplatonism group at the American Academy of Religion.
